## WHERE AS:


- 1. First party is an Educational Institution named as D.N.R.College (Autonomous), Bhimavaram.
- 2. Second party is a clinical testing lab as Sri Rama Chandra Aqua Lab, Bhimavaram involving in Clinical tests relating to Healthcare and cultivation of Fish and Prawns.
- 3. First party and Second party believe that collaboration and co-operation between themselves will promote more effective use of each other's resources and provide each of them with enhanced opportunities.
- 4. The Parties intent to cooperate and focus their efforts on cooperation within the area of research which involves healthcare and cultivation of Fish and Prawns to impart knowledge in tracing out the diseases and to find the steps to be taken medically relating to protect the Healthcare and cultivation of Fish and Prawns. ## NOW THEREFORE, IN CONSIDERATION OF MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

- 1. D.N.R.College (Autonomous), Bhimavaram which expression shall include its successors and assigns) on the ONE PART through its authorized signatory Dr. B.S.Santha Kumari, Principal, D.N.R.College.
- 2. Sri Rama Chandra Aqua Lab, J.P.Road, Bhimavaram on the Second Part through its authorized signatory is Smt A.Swathi, Proprietor.
- 3. The First Party has been offering Education in the areas of Sciences, Social Sciences, Technology, Arts, commerce and Management both at Undergraduate and Postgraduate levels.
- 4. The Second Party has been doing the clinical tests relating to the Healthcare Products of Fishy culture and Prawn culture.
- 5. The First Party shall provide theoretical knowledge to the Young Entrepreneurs who are the customers of the Second Party in the areas of Clinical tests and diagnosis, Research and development in the areas of Fish brooding, Prawn brooding, Fish cultivation and Prawn cultivation.
- 6. The First Party shall provide theoretical knowledge to the young entrepreneurs of the Second Party in the areas of remedial steps to be taken by the customers of the Second Party when diseases are spread in fish and prawn cultivation.
- 7. The Second Party shall provide hands on training to the students of the First Party in the areas of research and healthcare products for Fish breeding, Prawn breeding, Fish cultivation and Prawn cultivation subject to the availability of time to the Second party.
- 8. The Second Party shall provide internship programme to the students 3<sup>rd</sup> year students of B.Sc., Aquaculture and Life Sciences students of both UG and PG Programmes.
- 9. The Second Party shall conduct Campus placements to the eligible students of the First Party whenever there is requirement at their end.
- 10. To organize Seminars/Workshops/Conferences etc., with mutual cooperation and coordination of the both parties.
- 11. The First Party shall assist the young entrepreneurs of the Second Party through extending theoretical and technical knowledge in the area of clinical diagnosis.





- 12. To Second Party may permit the faculty and students of first party to utilize the infrastructure facilities available with them. It is not mandatory to the Second Party.
- 13. To organize common programmes in fulfillment of the concept of Institutional Social Responsibility.
- 14. To exchange the technical assistance of both the parties each other for the benefit of the students and faculty of first party and as well as the young entrepreneurs of the Second Party.
- 15. To nominate the Proprietor/Authorised person of the Second Party as Member in the Board of Studies committee under Autonomous setup of the first party.
- 16. The Second Party shall extend its advises to the First Party in review of curriculum which helps the students to meet the requirements of job market.
- 17. This MoU is valid for a period of 5 years from the date of signing the MoU by both the parties.
