Take print out of two copies of allotment order and joining report and report to the allotted College. Submit a copy of allotment order and joining report and obtain acknowledgement on 2nd copy of joining report from the College where you have reported and retain with you.

Both Self reporting and reporting at the allotted College is compulsory to retain the present allotment.
 The last date for Self reporting and reporting at the allotted College is 28.08.2019

4. If you do not report through self-reporting system and/or not reporting at the allotted college, the provisional allotment will be treated as a vacancy for the subsequent phase and the provisional allotment of 1st phase will automatically stands cancelled and you have no claim on the seat allotted.

The academic credentials verified if found false at a later date, your allotment will be cancelled and you are also liable for criminal prosecution.

6. Candidate is not required to deposit original certificates in the college at the time of admission.

The candidate can produce original certificates only for the purpose of verification in the college and can submit only Xerox copies in the college
