Submit a copy of joining report, allotment order and receipt of certificate and obtain acknowledgement on 2nd copy of joining report from the College where you have reported and retain with you.
4. The candidate is instructed that Self-reporting and reporting at the allotted college is compulsory to retain the present allotment. The last date for Self-reporting and reporting at the allotted college is **08.02.2021**
5. If the candidate do not report through self-reporting system and/or not reporting at the allotted college, the provisional allotment will be treated as a vacancy for the subsequent phase and the provisional allotment of 1st phase will automatically stands cancelled and the candidate have no claim on the seat allotted.
