RULES AND REGULATIONS

1. Name of the Association : D.N.R. College Alumni Association
2. Location of Office : D.N.R. College, Bhimavaram - 534 202.
West Godavari, A.P.

3. MEMBERSHIP :

The membership is open to all the old students of the D.N.R. College who are interested in promoting the association to achieve its aims and objects, subject to the approval of the Executive Committee. Persons desirous of joining as members of the Association shall pay an amount of Rs 50/- towards membership fee. After obtaining membership, every member shall abide by the rules and regulations.

4. TERMINATION OF MEMBERSHIP :

1. Those who resign for their membership in writing and whose resignations are accepted by the President of the Association.
2. Those who are expelled by the Executive Committee by a resolution passed in the Executive Committee meeting.
3. On his / her death.
4. He / She who becomes unsound minded.
5. He / She who has been declared insolvent.
6. He / She who has been convicted by any court of law.
7. He / She who is acting detrimental to the aims and objectives of the Association.

5. GENERAL BODY AND ITS FUNCTIONS :

The General body meeting of the Association will be held at least once in every year. During the meeting the following items of work will be transacted:

- a) To elect the members of the Executive Committee or confirm them.
- b) To approve the report of the activities of the Association.
- c) To pass the budget for the ensuring year and approve the expenditure statement of the previous year.
- d) To appoint an auditor to audit the Association Account.
- e) To ratify any proposal made by the Executive Committee.
- f) To transact any other matter for the benefit of the Association.
- g) To make any amendment(s) to the by laws of the Association.

6. SPECIAL GENERAL BODY MEETINGS :

Extraordinary or Special General Body Meetings may be convened by the Secretary in consultation with the President, or on the requisition of 3/5th members of the General Body.

Ten days notice shall ordinarily be given to members for the General Body Meetings. Five days notice shall be given to members for extraordinary or special General body meetings.

7. EXECUTIVE COMMITTEE AND ITS FUNCTIONS :

- (a) The Executive Committee shall consist of 26 Members i.e., (1) Honorary President, (2) President, (3) Vice-President, (4) Secretary, (5) Joint Secretary, (6) Treasurer and 20 E.C. Members.
- (b) The Executive Committee may co-opt upto Three members by passing a resolution and such co-opted members are not eligible for appointment as office bearers of the Association.
- (c) The supervision, control and management of the affairs of the association, its properties, (both movable and immovable) and finances shall be entrusted to the Executive Committee.
- (d) The Executive Committee may also transact any such other issues not specifically included in the agenda introduced by the Secretary, provided that there is quorum prescribed as per the by-laws.
- (e) In the event of death or resignation of any of the office bearers of the Association, the Executive Committee is authorized to nominate any member of the Executive Committee in the Vacancy caused and such person nominated shall continue in office only for the residual period of tenure of office of the office bearer.
- (f) The Executive Committee may ratify any such action(s) initiated by the President of the Association, provided that the committee is convinced of the urgency of such action(s) for the development of the Association.
- (g) The term of the Executive Committee shall be three years. A member whose term expires is eligible for re-election.
- (h) The members of the Executive Committee may be elected either unanimously or by election on such date and time and place as may be decided by the Election Officer appointed by the outgoing executive committee.
- (i) The President, Vice-President, Secretary, Joint Secretary and Treasurer and other members of the committee shall be honorary or fulltime workers. If they are full time members, they are entitled for sitting allowance or salary as may be decided by the executive committee.
- (j) The executive committee may appoint sub-committees for realization of the objects of the Association.

8. EXECUTIVE COMMITTEE MEETINGS

The Executive Committee shall meet atleast once in three months to transact any such agenda circulated to the members either by post or hand delivery under acknowledgement. Special or Extraordinary meetings of the Executive Committee may be convened by the Secretary in consultation with the President or on the motion of 3/5th of the members of the Executive Committee.

Seven days notice shall ordinarily be given to the members for the Executive Committee meetings. Two days notice shall be given to the members for the special or extraordinary meetings.

8. DUTIES OF THE OFFICE BEARERS

HONOURARY PRESIDENT

He shall be a person of academic excellence and an old student of this institution. He shall advice the members to achieve the objects of the Association.

PRESIDENT

- 1) He shall preside overall the meetings and see that the meetings are conducted properly.
- 2) He shall be responsible for the working of the Association.
- 3) He shall supervise and guide the overall actiyities of the Association.
- 4) He shall issue proceedings to the Secretary on all such matters approved by the Executive Committee for implementation.
- 5) He is authorized to direct the Secretary to take up any such steps in the interests of the Association subject to the approval of the Executive Committee.
- 6) He shall act as the Custodian of all the movable and immovable properties by acting as the constitutional head of the Association.

VICE - PRESIDENT

In the absence of the President the Vice-President shall act as President with the permission of the President. He shall assist the President in the activities of the Association

SECRETARY

All transactions of the Association shall be carried out in the name of the Secretary. The Secretary shall be the chief controlling and Supervision Officer of the Association and shall exercise all such powers delegated by the President in case of emergency. He shall closely watch the administrative and other measures directly affecting the interests of the members and initiate suitable action. In addition, The Secretary has the following powers also.

- 1) To sanction all the contingent expenditures of the Association.
- 2) To make proposals from time to time to create better facilities to the members and better amenities to the institutions started.
- 3) To take such suitable steps as and when necessary to augment the financial resources of the Association for the benefit of members and staff.
- 4) To adopt such rules for the internal management of the Association either with the approval of the President or subject to the confirmation of the Executive Committee.
- 5) Every expenditure shall be incurred only by the Secretary subject to approval by the Executive Committee on the advise of the President.
- 6) To transact any other matter for the benefit of the Association.
- 7) To call for the meetings of the General body, or Executive Committee with the consent of the President.
- 8) To keep accounts of all financial transaction of the Association and of all the sum of money received and spent by the Association and maintain records of receipts and expenses relating to such matters and of assets, credits and liabilities. Provided that the accounts shall be kept separately of all foreign donations / Charities / Contributions / Grants if any.
- 9) To get the accounts audited by the chartered accountant appointed by the Executive Committee at the close of the accounting year, every year.
- 10) To keep minutes of all the meetings of General Body / Executive Committee.
- 11) To keep and preserve the records of the Association / Executive Committee.
- 12) To submit to the Executive Committee the annual accounts and budgets of the Association.
- 13) To carry out all correspondence on behalf of the Association / Executive Committee.
- 14) He / She will be over all in-charge of administration and execution of all the programmes of the Association including financial affairs on behalf of the Executive Committee.
- 15) He is authorized to issue cheques or operate the bank accounts jointly with the Treasurer of the Association.

COMMITTEE MEMBERS

They will attend to the affairs of the Association as per the directions of the Executive Committee. They will attend to the other works relating to the Association and strive for the development of the Association

CO-OPTED MEMBERS

The co-opted members shall attend the meetings of the executive committee and strive for the development of the Association.

9. QUORUM:

The attendance of 3/5th of members of General Body Meetings and of 3/5th of Executive Committee meeting will constitute the Quorum. In case there is no quorum, the members present can not transact any other business, excepting the specific items included in the agenda.

10. FUNDS:

- a) The funds of the Association shall be spent only for the attainment of the objects of the Association.
- b) The funds of the Association shall be deposited on the name of the Association in any of the Nationalised banks in Bhimavaram only.
- c) The Bank pass book and cheque book shall be kept with the Secretary and the cheque book can be operated by the Secretary and Treasurer jointly.

12. ELECTIONS :

The Executive Committee shall pass a resolution deciding the date of election and appoint an ELECTION OFFICER who shall not be a member of the General Body and of the rank of the Principal, D.N.R. College.

14. DISSOLUTION :

Every year 31st March.









